## Legal

The legal environment in Guernsey is well established and there are numerous internationally recognised law firms offering a full suite of services for the finance industry. Fund regimes are regularly tested through the Royal Court of Guernsey. Modern company law remains advanced through continuous improvement in legislation.

## Tax

Guernsey has a standard 0% rate of income tax for corporate entities. Funds can elect to be exempt from paying income tax, although the payment of an annual fee is required for such concession. There is no withholding tax on dividends paid and no capital gains or VAT.

---

## Reputation

Guernsey's fund industry has successfully grown over five decades. During this time infrastructure and experience have developed on the Island and the accompanying intellectual capital accumulated ensures the Island remains at the forefront of fund centres globally. Fund business can be transacted with confidence in Guernsey; with bilateral public market access treaties with Australia, Belgium, Hong Kong, Japan, The Netherlands, Republic of Ireland, South Africa, Sweden, and Switzerland.

## Regulation

The GFSC promotes a robust, yet pragmatic competitive funds regulatory regime, adopting a risk based approach to ensure investor protection whilst avoiding unnecessary complex or burdensome regulation. The GFSC works closely with the funds industry to ensure that the regulatory regime continues to evolve and provide structures required by today's investors. This engagement between regulator and the funds industry has given Guernsey a track record in innovation, having created the "protected cell company" over 20 years ago. More recently, the launch of the Private Investment Fund regime reflects the often close relationship between fund managers and their investors. Continuity within Guernsey's democratic government offers political and economic stability and thereby a safe and secure environment on which businesses can rely. Legislative and fiscal independence allow the Island to respond quickly to the needs of businesses.
